Pricing:

Hodge Computer Systems, Inc. normal hourly rate for businesses is \$85.00 / hr. Within the scope of a Retained Services Agreement, please note the following discounted pricing information:

5 Hours Retained @ \$80 / hr. = \$400.00	(Regular Cost = \$425.00)
10 Hours Retained @ \$75 / hr. = \$750.00	(Regular Cost = \$850.00)
20 Hours Retained @ \$70 / hr. = \$1400.00	(Regular Cost = \$1700.00)
50 Hours Retained @ \$60 / hr. = \$3000.00	(Regular Cost = \$4250.00)

As you can see above, purchasing blocks of service offers considerable savings against our normal hourly rate and is billable in half hour increments.

Terms & Conditions:

Limitations & Excluded Services:
